## Terms and Conditions

1. Exhibit must be fully set up by 9:30am on Saturday, April 12, 2008.
2. Exhibitor agrees to be open and staffed during all show hours.
3. Exhibitor must not dismantle booth until after show closes, and must be completely moved out by 7pm, Saturday, April 12, 2008.
4. Exhibitor is responsible to assure necessary government permits and licenses are obtained.
5. All Exhibit material must meet fire and safety regulations. Fire Marshall or authorized agent reserves the right to confiscate or demand removal of any exhibit materials not meeting regulations.
6. Exhibitor shall not cause or permit any hazardous material to be used, stored, or generated on, or transported to or from the facility.
7. All electrical wiring must conform to city, county, and state Electrical Codes.
8. Exhibitor may not cause or permit beer, wine or liquors of any kind to be sold, given away, or used upon the facility.
9. Only one exhibitor may occupy assigned booth space unless Wine Country Radio gives prior approval.
10. Exhibitor may not sublet or re-assign the exhibit space contracted and shall not exhibit any merchandise other than specified in the Application.
11. Exhibitor agrees displays will not visually, physically, or audibly disturb aisles or adjacent Exhibitors.
12. No Exhibit material shall be attached by any method to columns, walls or floors or other parts of the building or furniture.
13. Exhibitor agrees that Wine Country Radio reserve the right to reject or restrict any exhibit, in part or whole.
14. Exhibitor agrees Wine Country Radio may change space assignments. Wine Country Radio will assign booths at its discretion and reserves the right to change any Exhibitor's assigned booth. Nothing contained in this application, Wine Country Radio acceptance thereof, or in any act or communication shall be construed as a guaranteed assignment to any specific booth.

Exhibitor assumes entire responsibility for exhibit area and hereby agrees to protect, indemnify, defend, and hold harmless Wine Country Radio, and their respective officers, directors, agents, and employees from and against any and all losses, charges, fines, and attorneys' fees arising or caused by the Exhibitor's installation, removal, maintenance, occupancy, or use of the exhibition premises or part thereof.
